Terms & Conditions:

1. A candidate must be either (i) a citizen of India or (ii) a subject of Nepal or (iii) a subject of Bhutan or (iv) a Tibetan refugee who came to over to India before 1st January, 1962 with the intention of permanently settling in India or (v) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India. Provided that a candidate belonging to categories (ii),(iii),(iv) and (v) shall be a person in whose favour a certificate of eligibility has been issued by the Government of India. A candidate in whose case a certificate of eligibility is necessary may be admitted to Interview but on final selection the offer of appointment may be given only after the Government of India has issued the necessary eligibility certificate to him/her.
2. Candidates already employed should apply through proper channel. They will be required to produce a 'No Objection Certificate' from their employer at the time of interview.
3. Mere possessing of the essential minimum qualification would not entitle a candidate to be called for interview.
4. The period of probation for the post shall normally be two years.
5. Duly filled up application form in own handwriting along with two recent sized photographs and copies of certificates & testimonials duly attested by a Gazetted Officer addressed to the Director, Central Institute of Himalayan Culture Studies, P.O.
