**EXTENSION ORDER**

In pursuance to the approval of the Competent Authority on the report submitted by the Committee constituted for the purpose of examining the performance of the contractual Teaching staffs for academic session 2024-25 vide no. 3-25/2025/CIHCS/2500-01 dated 23<sup>rd</sup> May, 2025, the services of the following persons to the posts as mentioned against their names in the table overleaf are hereby extended for a period of one academic session 2025-26 on **contract-basis** at the Central Institute Himalayan Culture Studies (CIHCS), Dahung w.e.f. 7<sup>th</sup> July, 2025.

The engagement is subject to the following conditions:-

**Terms & Conditions:-**

1. The contractual employees have no right to claim for regular appointment/regularization of the post after expiry of contractual engagement.
2. No Earned Leave is permissible except Casual Leave as per Central Civil Service Leave Rules.
3. During the contractual engagement period he/she is not entitled for Medical Re-imbursement; Winter Allowance; Children Educational Allowance; Re-imbursement of Tuition fees; Leave Travel Concession (LTC); Special Compensatory Allowance etc.
4. The contractual employees have to report his/her duty at posting place on or before 7<sup>th</sup> July, 2025, failing which his/her extension order will automatically be treated as cancelled.
5. She/he is not entitled to subscribe to GPF or CGEIS or such other welfare schemes during the period of part-time engagement.
6. The engaged employees are also to work as per the directions of the Director, CIHCS, Dahung in addition to his/her normal duties.
7. No representation will be accepted for change of posting place.
8. The employee will not be entitled to residential accommodation in the campus.
9. The Institute reserves the right to terminate the service of the employee at any time.

The other terms & conditions of engagement not specified herein shall be governed by the Bye-Laws of the Institute/as per the existing norms of Govt. of India.
